## STEP FORWARD MICHIGAN MORTGAGE AND TAX ASSISTANCE PROGRAM

The Monroe County Treasurer is partnering with the Michigan State Housing Development Authority (MSHDA) on the Step Forward campaign to prevent home foreclosures due to unpaid property taxes. MSHDA has more than \$500 million available in the Helping Hardest Hit Homeowners fund, and we are working together to preserve the dream of homeownership. According to County Treasurer, Kay Sisung, qualified applicants could be eligible for up to \$30,000 in assistance through the Loan Rescue Program that helps homeowners who have fallen behind on their mortgage and/or property taxes. The loan is provided at 0% interest rate, requires no monthly payments, and will be forgiven at 20% each year as long as the property remains the homeowner's primary residence. Legal description of home with parcel ID number (Tax bill, Deed, Mortgage note, Title Insurance Policy)

*If self-employed:* Last 30 days Profit-Loss statement AND the most recent year income tax return
